## DEPARTMENT OF AGING AND ADULT SERVICES COMMISSION (DAAS) MINUTES OCTOBER 4, 2017

#### CALL TO ORDER AND ROLL CALL

Interim-President Gustavo Seriñà called the meeting to order at 9:35 AM.

The (DAAS) Commission Secretary called the roll.

President (Interim) Gustavo Seriñà congratulated Commissioner Katie Loo on her reappointment and welcomed Commissioner Tedi Vriheas to the DAAS Commission.

## **Executive Director's Report**

Executive Director Shireen McSpadden also congratulated Commissioner Katie Loo and welcomed newly appointed Commissioner Tedi Vriheas. Ms. McSpadden announced that DAAS along with the San Francisco Interfaith Council are coming together to initiate a faith forum. This is a great opportunity for our partners, faith communities and DAAS to come together discuss how we can jointly better serve older adults and adults with disabilities. Ms. McSpadden believes that this is the first Interfaith Forum to be created in San Francisco and is something that she has wanted to establish for a few years. The Interfaith Forum will take place on Monday, October 16, 8:30-12:00 PM at St. Mary's Cathedral. Shireen also commented that the Dignity Fund Community Forums will take place in each of the eleven districts. Each member of the Board of Supervisors (BOS) is expected to give opening remarks. Bridget Badasow the DAAS Commission Secretary can distribute the schedule for each community forum. In addition to that, DAAS will hold at least thirty focus groups to really understand the needs of older adults. The California Welfare Director's Association (CWDA) conference began today in Sacramento. Ms. McSpadden and HSA/DAAS staff will be attending this conference immediately after Commission. Ms.

McSpadden was excited to announce that this CWDA conference will be the first time that the focus will be on aging and immigration.

## EMPLOYEE RECOGNITION:

Executive Director Shireen McSpadden and the DAAS Commission recognized Dimitra Stathopolous an Adult Protective Service (APS) worker from DAAS's APS office. Ms. McSpadden thanked Ms. Stathopolous and all of the DAAS APS workers for their hard work and dedication.

## ADVISORY COUNCIL REPORT/President Leon Schmidt

Mr. Schmidt stated that the Advisory Council met on Wednesday, September 20. Mr. Schmidt recognized and congratulated Advisory Council member's Ms. Beverly Taylor for her 'Transportation' article, Dr. Marcy Adelman for her 'Heat Wave and Older Adults,' article and Patti Spaniak for her Cayuga Community award. Ms. Schmidt announced that DAAS staff person Melissa McGee updated the Advisory Council on the Dignity Fund. Finally, the Advisory Council is working with the San Francisco Public Library to create an information Hub for seniors.

### ADVIOSRY COUNCIL'S JOINT LEGISLATIVE COMMITTEE REPORT/Diane Lawerence

- 1. Joint Legislative Committee Items
  - a. The Committee tracked 34 bills this first year of the 2-year session
    - 8 were signed by the Governor
    - 10 were enrolled and are awaiting the Governor's signature
    - 1 was vetoed
    - 14 had no action taken by the end of the session and will probably become a 2-year bill.
    - 1 never made it out of committee.
  - b. Signed bills include
    - Cash Surrender Benefits (AB 1398 Kalra)
    - Physical and Sexual Abuse Awareness Training (AB 326 Salas)
    - Increased Enforcement of Existing State Housing Laws (AB 73 Chiu)
    - Ombudsman Role in Skilled Nursing Facility Discharge. (AB 940 Weber)
    - Housing Affordability and Accountability (SB 35 Weiner)
    - Long Term Care facilities would have to provide earlier notice of closure—60 days rather than 30. (SB 275 Wood)
    - Continuing Care Retirement Community to dispute a transfer decision. (AB 713 Chui)
    - Affordable Care Housing Bond Act of 2018—allow for a \$3 billion dollars bond issue to go before the voters. (SB 3 Beall)
  - c. Vetoed Bill was Elder and Dependent Adult Abuse which would have added the preponderance of evidence to elder abuse cases. (AB 859 Eggman)

a. Uncertainty continues with regard to funding of various programs and health care.

  - a. No additional information on the impacts on the Older Americans Act which was just reauthorized last spring.

- Learn about and support <u>No Place Like Home</u> (state capital funding for people with serious mental illness) to create more supportive housing units.
