# Executive Director's Report/Deputy Director Cindy Kauffman

Deputy Director Cindy Kauffman reported the Executive Director Shireen McSpadden is in Washington DC attending the National Association of Area Agencies on Aging (N4A) board meeting. The N4A will be working on their policies at a national level this week. Ms. McSpadden will also have the opportunity to meet with our representatives on Capitol Hill. California will begin its' two-year legislative process. DAAS and the Human Services Agency (HSA) as a whole are currently looking at their policy priorities. State associations as well as the California Senior Legislature (CSL) are also developing their proposals at this time of year. Some important dates to remember as far as proposals are: January 10, 2019 the release of the

governor's budget, January 25, 2019 the last date to submit bill requests to the Office of the Legislative Council and February 22, 2019 is the last date to introduce a bill(s). The DAAS Joint Legislative Council will begin their monthly meetings in February 2019 and at the same time begin to review relevant proposals that relate to DAAS. Another key date to remember is December 10, 2018 which is when Mayor London Breed will release her budget instructions. Ms. Kauffman mentioned that DAAS is currently being audited by the California Department on Aging (CDA). The CDA is currently auditing our AAA programs for which they provide funding. This is a very thorough, significant and major audit which occurs every four years. Ms. Kauffman thanked and gave credit to staff for all their hard work and preparation for this audit. Finally, Ms. Kauffman also mentioned that the Dignity Fund Oversite Advisory Committee (OAC) as a follow up-to the needs assessment, will be presented with a deeper dive from the planning office into the equity analysis of communities of color and the LGBTQ population.
